## Types of Bequests

There are two types of bequests:

### Unrestricted Bequests

These are bequests where the benefactor bequests the gift with no restrictions on the use of its use by the Peace Foundation.

### Designated Bequests

These are bequests where the benefactor stipulates a restriction on the use of the bequest – this may be that the bequest is designated an area like human rights or social justice. It may also be restricted to a particular project or priority like the Kaurna Walk, Grant or Scholarship.

## Suggested Wording

The Peace Foundation recommends the following wording be placed in your Will, although it is recommended that you speak to a financial adviser and/or lawyer when making your Will.

### Wording for making an Unrestricted Bequest

I bequeath to The Graham F. Smith Peace Foundation Incorporated, ABN 26045549708, for the general purpose of the said organisation and free of all duties and taxes, the following:
