Referendum: Enshrining the First Nations Voice to Parliament A Community Campaign Toolkit

The Graham F Smith Peace Foundation (Peace Foundation) is committed to the **Uluru Statement from the Heart**: a gift of hope, love, and peace from First Nations Peoples given to **all** Australians in 2017 to create a better and united Australia.

We welcome the decision of the Federal Labor Government to hold a **Referendum** within the life of the current parliament to enshrine a First Nations Voice to Parliament in the Australian Constitution as proposed in the Uluru Statement.

To be successful a Referendum requires a national majority of voters in all states and territories **and** a majority of voters in a majority of states (at least four out of six states).

The Peace Foundation is dedicated to achieving a successful Referendum, in collaboration with others.

An active and determined campaign will be required to gain the Referendum. It will need to be based on accurate information and counter opposition feeding on misinformation and anxiety about change. Moreover, it will need to start **now** before misinformation and opposition become entrenched.

The Toolkit is designed to help each one of us to:

- Be informed and to act
- Join our voice with others to amplify our message
- Stand up for Recognition everywhere and invite others to join in.
- Share, participate and add to messages and actions from the Peace Foundation (members, donors, and supporters) as well as from allies, affiliate organisations, and coalitions which we support or of which we are part, using email, social media, and any other communication channels available.
- Organise and mobilise for Referendum Day – starting now!

This Toolkit contains resources we need to be informed, and get started to formulate, coordinate and execute individual or group campaign plans as follows.

The Uluru Statement from the Heart – foundation information

- **The Uluru Statement from the Heart** is the foundation document written by **the Aboriginal and Torres Strait Islander people on the last day of the Convention, May 2017, inviting all Australians to “walk with us in a movement of the Australian people for a better future”**. It calls for structural reforms including constitutional change to establish a Voice to Parliament enshrined in the Constitution, a Makarrata Commission to supervise a process of agreement-making and truth-telling: **Voice, Treaty, Truth**.

It highlights the **History is Calling** movement. The 15-member team responsible for the website includes the indefatigable Co-Chairs, Pat Anderson AO, and Professor Megan Davis. This is a most impactful website. - ***Finding the Heart of the Nation* by Thomas Mayor, 2022**
This book by Torres Strait Islander Thomas Mayor is for all Australians, tells the story of the Uluru Statement from the Heart of which he was a signatory. Following the Uluru Convention, Thomas was delegated to carry the sacred canvas of the Uluru Statement from the Heart around the country. The journey took eighteen months during which he garnered support for a constitutionally enshrined First Nations voice, and a Makarrata Commission for truth-telling and treaties. Thomas's journey as a tireless campaigner continues, both in person and through the pages of his book which is his gift to the campaign for Voice, Treaty and Truth.

Adopt an Action Plan

Along with the knowledge and tools above, here is a selection of actions that can help to create a Community Campaign to achieve a successful Referendum which will move Australia towards a more unified future. We all have the opportunity and power to do this. Choose actions or develop your own to include in an Action Plan that you wish to adopt for yourself:

1. Be informed about the **Uluru Statement from the Heart** and talk about it with friends, family, colleagues, and acquaintances. See ulurustatement.org/

2. Get to know the **From the Heart** website and sign up to receive information from Director, Dean Parker.

Here you can take the course on **A Voice to Parliament** fromtheheart.com.au/education . The course covers what is meant by Indigenous Constitutional Recognition through a Voice and why a Referendum is required to make it happen. This experience will take about 15 – 20 minutes. 3. Sign your name on the Uluru Statement Canvas on the **From the Heart** website. Invite family and friends to join you in the signing.
4. Share your experiences and impressions across all social media channels to which you have access; generate a conversation. Encourage others to use **Facebook, Instagram, Twitter, and LinkedIn.**
5. Write to politicians, state, federal and local government, regularly. Letters of encouragement can be useful for those who support the Voice, but it is also important to write letters to those who oppose the Voice.
6. See letter writing messages at ulurustatemdev.wpengine.com/take-action/write-to-your-mp/ which can be adjusted to meet special needs.
7. Organise groups at home, work or at social events to discuss the Voice to Parliament. See ulurustatement.org/
8. Be prepared for exchanges and opposition in discussions about the Referendum. The best approach is to be calm; ask questions; acknowledge concerns; answer honestly; respond by sharing information rather than argument and offer to seek out answers to matters unknown and respond immediately.
9. Prepare responses to:

Counter Misinformation e.g. the Statement is unrepresentative of First Nations views; the Voice will be a third tier of Parliament; it is undemocratic; it will be ineffective; we need a treaty first.

Respond to Prejudice e.g. First Nations Peoples already get more than the rest of us; they just waste opportunities; it will be a waste of time and resources – look at ATSIC(Aboriginal and Torres Islander Commission)

Deal with Anxiety about change e.g. things are ok as they are; this could corrupt democratic processes; there is too much change happening already; its structure and powers are unclear; I can't vote for something so vague.

Deal with Misdirected Anger e.g. I've got too much to worry about already; I'm sick of hearing about them; what about my troubles with the mortgage, bills; nobody listens to us; how is it going to improve things; there are more important things to worry about.

Switch people who are switched off e.g why should I care; it's got nothing to do with me.

Please Take Action

Let us together, respond to the invitation from our First Nations sisters and brothers in a nation building project to *“unite at long last the First Peoples of this country with our British institutional inheritance and our multicultural achievement, under the Constitution.”* – Noel Pearson's Boyer Lecture 2022.
